CITY COUNCIL MEETINGS are held on the 2nd Monday of the month at 6:30 p.m. in the Conference Room of the Hall and are open to the public.

Office Holiday closings: There are no city holidays (except New Year's Day) in the months of January, February and March. We are open!

CHRISTMAS TREE PICK UP: The DPW will pick up trees Wednesday January 7, 2015. Place your tree curbside with the trunk to the street.

**DPW SNOWPLOWS STREETS:** Do not park on the street between 2:30 a.m. to 6:00 a.m. or during declared snow emergencies.

WHILE ON THE TOPIC OF SNOW **REMOVAL:** We all clear our driveways and walkway to our houses of snow, but PLEASE DO NOT PUSH THE SNOW INTO THE STREET. Besides making it harder for the guys plowing, it is against the law.

TRASH: Curbside collection is Monday. Pick up is delayed one day in the event of a holiday or major storm occurring on a Monday.

# WATER / DPW

BILL by Jan. 26, 2015 and the remainder by Feb. 25, 2015 without any late fees attached. We accept payment on accounts

**ZONING ADMINISTRATOR OFFICE HOURS:** Terry Kelly is in the Office Friday mornings (9 a.m.-12 Noon) OR by appointment. See or call him for Site Plan Reviews or zoning issues before starting a project.

Building Permits require a City Zoning Site Plan Review & D.P.W Clearance Sheet. A Review is required before any ACTION remodel, new construction or a new / change of business. The filing fee doubles if work is started before obtaining review.

# CAMPING:

Contact either the Huron County Road Commission's Parks Department or the State of Michigan for camping information and or reservations.

The CITY <u>does</u> <u>not</u> <u>own</u> any campgrounds or parks with overnight facilities.

# WINTER TIME REMINDERS:

- SIDEWALK SNOW REMOVAL: The owner or occupant of any lot or parcel shall be responsible for the removal of snow and ice from any sidewalk located adjacent & in front of such lot or parcel.
- LOSS OF WATER Caused by Failure to Turn Off Service: It shall be the responsibility of every property owner who will be absent from their property for an extended period during the winter months to contact the City and have the water to their property turned off.

If a property owner fails to notify the City to turn off their water and a line break occurs between the curb stop and the house meter due to freezing temperatures, then in such event, costs may be assessed by the City Council against the property owner.

- •FLUSH YOUR SYSTEM Regular periodic maintenance includes cleaning the screens on faucets & appliances to remove grit collected from the water.
- ON THE TOPIC of FLUSHING Toilets: P-L-E-A-S-E do not flush any type of diaper, mop or cleaning rags down the toilet!!!!!

THERE IS NO CHARGE to turn your water off or on by the DPW during the workweek. Call the Water Plant at (989) 856-4407 Monday – Friday, 7:00 a.m. to 3:00 p.m.

No one need be present to turn the water off. You will be billed if they are called in after hours or on weekends.

To turn water on: someone has to be present with access into the house (a key). We won't turn water on unless the house is checked for leaks.

maintained by the Clerk's Office. To be on the list to automatically receive applications for Absent Ballots, submit a letter of request to the City Clerk's office.

We need your name, registered address, mailing address and a reason. Include the <u>correct</u> mailing address. For those who use a PO Box, please include that information in your request.

# HOUSE NUMBERS <u>Are to be posted</u> facing the <u>addressed street</u>.

If your lot is a corner lot with your house entrance to the side street, the numbers should face the <u>street of address</u>. You may still place numbers by your front door (wherever it is locate on your building) in addition to posting numbers as required.

This is to aid rapid response by FIRE, POLICE, E.M.S./RESCUE & 911 SERVICES.

**NEEDED: VOLUNTEERS** for City boards and commissions. The city supplies the training and materials needed for all volunteers.

# DOG LICENSES ARE AVAILABLE!

We sell dog licenses through February 28, 2015. They cost \$15 (male or female) or \$10 if the pet is unsexed. The licenses are also sold by the Township and the Caseville Small Animal Clinic.

After that, licenses are available only at the Huron County Treasurer's Office for \$30.00.

### TAXES

As a resident and or property owner in the City of Caseville, you will receive **2** Tax bills in the year 2015:

- 1. Summer Tax July 1 State Education Tax (S.E.T.) County Operating Tax
- 2. Winter Tax December 1 Includes millages for Huron County, Caseville City, Caseville DDA, Caseville Public School, Huron County ISD and Special Assessments.

The CITY collects winter taxes beginning December 1: All taxes are to be paid <u>by</u> the end of February. Since that is a weekend, the last day to pay taxes is March 2, 2015 by 4:00 p.m.

POSTMARKS ARE NOT ACCEPTED as payment dates.

Unpaid taxes as of March 3<sup>rd</sup> are deemed delinquent and turned over to the Huron County Treasurer who adds a 4% administrative fee on the tax.

Late taxes accrue a penalty of 1% per month.
