**RESOLUTION #2023-65,** ROLL CALL, by Sprague second by Tait to recommend the Planning Commission develop an ordinance allowing recreational marijuana facilities in the city. **Roll Call Vote Failed (1 Yay - Sprague, 4 - Nays Rathje, Talaski, Tait & Braun).**
