# **NEW BUSINESS:**

MOTION Carried, by Sprague second by Ignash to approve the Chamber of Commerce's request to host the 1st Annual Caseville/Saginaw Bay Power Boat Run at the Caseville Resort and Marina on August 22 through August 24, 2025. This request also exempts American Custom Marine-Kimball from the vendors fee to sell shirts during this event. 6-0 Approved.

**MOTION Carried,** by Sprague second by Tait to approve the Chamber of Commerce's request to conduct the "Market on Main" on Saturday's from 11:00 a.m. to 3:00 p.m. May 24 through October 4, 2025 at the Main Street Park, excluding Cheeseburger weekends. This would also include closing Pine St. from Main St. to Prospect St, only when additional vending spaces are needed. **6-0 Approved.** 

**MOTION Carried,** by Sprague second by Hervert to approve the Chamber of Commerce's request to conduct its annual "Trash & Treasure Days", May 22 through May 26, 2025. This excludes participants from garage sale permit requirements for this sale. **6-0 Approved.** 

**MOTION Carried,** by Tait second by Sprague to approve the Caseville Chamber of Commerce's request for the 3rd Annual Caseville Cruise Night on May 31, 2025. **6-0 Approved.** 

**MOTION Carried,** by Sprague second by Kretzschmer to approve the Caseville Chamber of Commerce's request to host the Annual Caseville Country Ribstock Festival on June 27 through June 29, 2025. **6-0 Approved.** 

**MOTION Carried,** by Sprague second by Kretzschmer to approve the Caseville Chamber of Commerce's request to hold the Fireworks on July 5, 2025. **6-0 Approved.** 

**MOTION Carried,** by Tait second by Sprague to approve the Caseville Chamber of Commerce's request to host the Cheeseburger in Caseville events August 8 through August 17, 2025. **6-0 Approved.** 

**MOTION Carried,** by Tait second by Ignash to approve the Caseville Chamber of Commerce's request to host the Pumpkin Festival September 20, 2025. **6-0 Approved.** 

**MOTION Carried,** by Tait second by Sprague to approve the Caseville Chamber of Commerce's request to host the Witches Walk on October 25, 2025. They are requesting street closure during this event on Main St. **5-1 (Rathje Nay) Approved.** 

**MOTION Carried,** by Sprague second by Tait to add 24 hours per week of part-time police coverage, until the Police Committee has the opportunity to review the budget. **6-0 Approved.** 

**RESOLUTION #2025-16**, ROLL CALL, by Rathje second by Tait to accept the bid from Dufty's Excavating LLC for \$157,708.57 to construct the boat launches at Riverside Park, after approval of the bids from the Michigan DNR. **Roll Call Vote Approved 6-0.** 

**RESOLUTION #2025-17,** ROLL CALL, by Rathje second by Tait to approve the agreement with SAFEbuilt Michigan LLC, on an interim basis, to conduct the plumbing inspections for the city until a permanent plumbing inspector can be hired. **Roll Call Vote Approved 6-0.** 

**RESOLUTION #2025-18,** ROLL CALL, by Tait second by Sprague to submit Congressional Direct Spending applications for water system replacements and repairs and commit to a 20% match of any grant funds received through these programs. **Roll Call Vote Approved 6-0.** 

## **PUBLIC COMMENTS:**

Mike Muscat asked if there was an ordinance to prohibit alcohol consumption in public, why allow the trolley. Scott Maust said Thumb Area Transit was building a new facility that will be paid for with state and federal funds. He said the Road Commission is seeking funding to build a new building.

James Smith said open alcohol for the trolley is a bad idea and he was happy to hear people are wanting to work police shifts.

Lou Johnson commented that the trolley doesn't travel more than 5 m.p.h. when under pedal power. Raymond Quiel supports \$30,000 for additional police coverage.
