Patty McKinley asked about implementing a registration program for golf carts and side by sides.

Clyde Campbell commented he doesn't use Facebook.

Robert Pillsworth asked about "colors" at the event. Organizer said no "colors" or patches allowed. He commented that there are so many people getting pulled over. 20 years ago police were running people out of town with tickets. Ambulance and "bikers" are driving too fast through town.

Wendy Waldrep said she has heard complaints about police. They are more negative than ever. She commended Officer Howard.

Michael Muscat commented on difference of vending fees. Sprague said the church also got a break and the veterans are different.

Debra Estep introduced herself and asked for votes for council seat.

Jamie Learman disagreed with Pillsworth's statement. As police chief then he stated they weren't writing a lot of tickets and running people out of town as Pillsworth stated.
