CALL TO ORDER:

Hopkins said the cadets are done with training and are working on their own.

RESOLUTION #2023-47, ROLL CALL, by Braun second by Ignash to approve the Chamber of Commerce request for the closure of Pine St. from Main St. to the parking lot entrance for use after the parade and allow two food trucks to operate at no cost in the closure area. **Roll Call Vote Approved 5-0.**
