RESOLUTION #2021-12, ROLL CALL, by Tait second by Sprague to purchase a 2022 International truck chassis and equipment from Tri County International and upgrade it to a dump truck with underbody scraper, with additional equipment installed by Shults Equipment of Ithaca at a cost not to exceed \$140,000. **Roll Call Vote Approved 4-0.**

RESOLUTION #2021-13, ROLL CALL, by Tait second by Sprague to purchase a 2021 Ford F-150 from Ordus Ford at a cost not to exceed \$37,000.

Kenneth Rathje talked about the need for the April meeting. At this time, the members felt there was no need for the April 12 meeting. A motion was introduced.

MOTION, by Sprague second by Tait to cancel the April 12, 2021 Council meeting. 4-0 Approved.

PUBLIC COMMENTS:

Hartz talked about a raw water line break from the lake to the water plant. He also spoke about an air compressor that went down at the water plant and the generators were tested at both the low lift and the water plant.
