Troy Hartz spoke about Karl Krull resigning from the water department and the water main break last month out in Caseville Township. Jamie Learman talked about the election tomorrow. Chief Romzek said the MDOT ORV Connector Route permit application has been approved. They now have to order the required signs, have the sign placement inspected by MDOT and then once MDOT approves, golf carts will be allowed on M-25 from Michigan St. to County Rd.

Clyde Campbell encouraged the Council to vote to ban marijuana sales. He also thinks the Council should end the DDA. Finally he encouraged voters to vote against the Caseville School bond proposal.

James Smith said he agrees with Clyde on the school proposal. He also said he is happy he has been seeing more police patrols recently near his neighborhood and wants the police to enforce the fireworks ordinance. Laura Horkey asked Chief Romzek some additional golf cart questions.

#### **PUBLIC COMMENTS:**

James Smith said the Council is headed in the right direction on marijuana. He asked what streets will be paved next and stated the golf cart rules will confuse a lot of people.

Clyde said he was glad they are moving the marijuana ban forward, he is afraid of the golf cart ordinance and rules and would like to see restrictions on kids.

Louis Johnson asked Chief Romzek if he was all set for Cheeseburger. Romzek said he was.

Derek Guster thanked the Council for the opportunity to speak and said he was not happy that the Council was moving to ban commercial sales of marijuana.

Jamie Learman reminded everyone to vote at City hall tomorrow for the school bond.

# **COUNCIL COMMENTS:**

Talaski said once the golf cart rules get set, the City will put something together to clarify for everyone. He said the D.P.W. will do a great job cleaning up every morning during Cheeseburger and reminded everyone to vote tomorrow. Sprague said he feels that marijuana is an enterprise opportunity for people.

Rathje said he is not in favor of commercial marijuana sales, but is ok with medical sales.

Des Jardins thanked Talaski for his letter to the editor and thanked everyone for coming.
