Rating of service or feeder in amps _____ Size of building in square feet _____ . Plans are REQUIRED for all building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to act 299 of the Public Acts of 1980, as amended, and shall bear the architect's or engineer's signature and seal, except:

1. When the electrical system rating does not exceed 400 amps and the building is not over 3500 sq. ft. in area.
2. Work completed by the governmental subdivision or state agency costing less than \$15,000.

5. APPLICANT SIGNATURE

Section 23a of the State Construction Code Act of 1972, 1927 PA 230, MCL 125.1523A, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who are to perform work on a residential building of a residential structure. Violators of Section 23a are subjected to civil fines.

I hereby certify the electrical work described on this permit application shall be installed by myself in my home in which I am living or about to occupy. All work shall be installed in accordance with the electrical Code and shall not be enclosed, covered up, or put into operation until it has been inspected and approved by the Electrical Inspector. I will cooperate with the Mechanical Inspector and assume the responsibility to arrange for the necessary inspections.

6. EXPIRATION/ CANCELLATION OF PERMIT: A permit shall become invalid (expire) if the authorized work is not complete within 12 months after issuance. A six-month extension may be granted at the cost of \$50.00 if requested in writing prior to permit expiration date. Expired or extended permits cannot be refunded or reinstated. An administration fee of \$50.00 will be charged to all permits canceled within the first 12 mos.

7. FEE CLARIFICATION: When installing a site in a park, the permit application must include the application

fee, service plus the number of park sites. Work must be done by a licensed electrical contractor.
